Relevance of Project

Traditional energy security responses:

- Building of strategic petroleum reserves
- Expansion of exploration and production activities
- Acquisition of foreign energy assets
- Massive investments in clean energy technologies

Relevance of Project



Existing studies all have a fragmented nature and cannot provide an all-round up-to-date review of the available policy options for energy resource diversification in the APEC region



Existing researches predominantly extrapolate the EU experience in energy resource diversification on APEC Member Economies and do not take into account the APEC regional conditions

To outline the common APEC energy resource diversification strategy

To elaborate the visionary roadmap for energy resource diversification, potentially contributing to more balanced energy resource diversification strategies of the APEC region

Alignment

The proposed project is in line with APEC current strategic objectives and priorities:

- **2007 Darwin and 2010 Fukui Declarations** brought the issues of energy security to the top of APEC's agenda
- **2012 St. Petersburg Declaration** defined the main challenges and strategic choices for energy security
- **Indonesia as the host of APEC-2013** has been repeatedly stressing the urgent need for energy resource diversification in the APEC region



Project Timeline

March 2013 – December 2013 (9 months)

Three stages of Project execution:

Stage 1: Policy options for energy resource diversification (March-August 2013)

Stage 2: APEC common energy resource diversification strategy (September-October 2013)

Stage 3: Visionary roadmap for energy resource diversification (November-December 2013)
